INTRODUCTION AND PURPOSE

Definitions

College: For the purpose of this policy, any reference to 'College' or 'the College' refers to Duchesne College.

Student: An individual person who is formally enrolled at the College as either a resident or associate member.

SCOPE

GENERAL BEHAVIOUR AND PERSONAL CONDUCT

As a student of Duchesne College you are expected to:

- Contribute positively to the Duchesne College community and display a responsible, respectful attitude at all times.
- Contribute to a harmonious, respectful and fun-living College environment.
- Conduct themselves in a disciplined manner when representing the College, including within the University and in mentoring, external or internship contexts.
- Treat all students, staff, alumnae, Council members, volunteers, any visitors to the College and any other members of the public with respect, dignity, impartiality, courtesy and sensitivity.
- Ensure a warm welcoming approach to all residents and associates to forge strong inclusive relationships throughout the College.
- Act honestly and ethically in their dealings with the College, respective university or other institution, and all persons cited above.
- Not engage in any activity which has the potential to bring the College into disrepute.
- Maintain a cooperative and collaborative approach to inter-personal relationships.
- Read and respond respectfully as required to all official correspondence from the College, including email and telephone messages and meet required deadlines. Students should note that the College staff communicate directly with students, rather than their parents or guardians, except in extenuating circumstances as deemed appropriate by the Head of College or delegate.
- Respect the privacy of students, staff, alumnae, Council members, volunteers and any other members of the public.
- Never engage in illegal activities. This may result in cancellation of residency or associate membership at the College.
- Honour their financial commitments to the College.
- Abide by all College policies and procedures as amended from time to time.
- Treat all College property with care and respect.

RESPECT AND SUPPORT

All students must contribute positively to an environment free of discrimination and harassment. Students must treat each other, staff, and other members of the broader College community in a fair, respectful, and equitable manner including but not limited to:

- Acknowledging and respecting the cultural background of this land and its Traditional Owners and Custodians.
- Acknowledging and respecting the diversity of the College community.
- Communicating in a tone that is not offensive, aggressive, rude or insulting.

- Maintain effective and safe functioning of the College.
- Adhere to the College workplace health and safety guidelines and requirements.
- Adhere to the COVID Safe Action Plan.

PRIVACY AND CONFIDENTIALITY

All students must:

- Respect the privacy of students, staff, alumnae, Council members, volunteers and/or any other members of the public.
- Respect the confidentiality of information shared within the College environment.

COMMUNITY ENGAGEMENT

The College expects all students to undertake the following responsibilities to support and enhance the spirit of its community:



- Attend all formal dinners and events, including professional engagement opportunities unless exemption has been granted by the Head of College or delegate.
- Participate in Inter-College Council (ICC) activities and events, where practicable.
- Participate in College service initiatives.
- Participate in Resident Leader family activities.

Consequences will apply to any student who is involved in a misdemeanor or serious incident. The following table will be used as a guide.

Level 4	Drug use and/or supply	<ul style="list-style-type: none"> • Should it be deemed that the incident be reported to police, this matter has then moved beyond the procedure • Further consultation with parents/guardians and other administrative and law enforcement bodies may be required
